San Francisco Department of the Environment 5207 Associate Engineer – Heating Systems

Program Background: The mission of the City and County of San Francisco Department of the Environment (SF Environment) is to improve, enhance, and preserve the environment, and to promote San Francisco's long-term environmental well being. SF Environment includes Recycling, Toxics Reduction, Environmental Justice, Clean Air Transportation, Climate Change, Energy, Green Building, Urban Forest and Public Information Programs. The Energy program currently operates the Energy Watch program (www.sfenergywatch.org) that provides incentives and technical assistance for energy retrofits in existing commercial and multi-family buildings in San Francisco. The Energy program has recently received Federal funding through the American Recovery and Re-investment Act (Stimulus) to accelerate retrofits of heating systems in multi-family buildings and single-family buildings.

Position Description: Under supervision of the Energy Efficiency Program Manager, the 5207 Associate Engineer will design and manage energy efficiency retrofits of heating systems in multi-family, single-family and commercial buildings. The Associate Engineer will also provide technical supervision to assigned technical staff, consultants and vendors. Duties may include but are not limited to the following:

1. Discusses energy efficiency and energy generation opportunities with customers.
2. Prepares engineering designs, drawings, and specifications to ensure compliance with codes, standards, and project requirements.
3. Prepares cost and quantity estimates for labor, materials, and equipment associated with construction.
4. Prepares energy savings estimates for kWh, kW, and therms.
5. Prepares estimates of incentive funds to be paid to customers and vendors.
6. Works with vendors and City procedures to have energy efficiency technologies installed in private facilities.
7. Provides technical oversight to work performed by assigned staff and consultants.
8. Determines resources needed to complete assigned work.
9. Tracks and reports project progress.
10. Performs post-construction reviews of installations for quality assurance.
11. Presents to staff, committees, boards, commissions, as well as business and civic organizations.
12. Participates in program planning, program coordination, and departmental activities.
13. Prepares and supervises the preparation of a wide variety of technical engineering reports, regulatory reports, procedures manuals, and other documentation.

14. Interviews, trains, monitors, evaluates and counsels staff in accordance with appropriate MOUs, Civil Service Commission rules, and departmental procedures.
15. Other duties as assigned.

Minimum Qualifications:

1. Three (3) years verifiable professional mechanical engineering experience that includes two (2) years experience equivalent to or higher than a 5252 Assistant Mechanical Engineer, AND
2. Possession of a Certificate of Registration as a Professional Engineer in the State of California in Mechanical.
3. Must have valid Driver's License.

- Three years experience in designing and/or project management of retrofits of boilers and other heating systems in buildings;
- Experience designing and/or project management of co-generation systems in buildings;
- Demonstrated ability to work in a team;

- Fluency in other languages used commonly in San Francisco

VERIFICATION:
