

1 [Commendation for Urban Forestry Council Member Jocelyn Cohen]

2 Resolution commending Jocelyn Cohen for her service and dedication to the City and
3 County of San Francisco's Urban Forestry Council and for improving San Francisco's
4 urban forest.

5 WHEREAS, Jocelyn Cohen was appointed to the Urban Forestry Council by the
6 Board of Supervisors on February 4, 2005 as a representative of the community and
7 then reappointed on December 16, 2008 to a seat that must be certified by a
8 professional tree management organization; and,

9 WHEREAS, Jocelyn Cohen has served the City and County of San Francisco as
10 a member of the Urban Forestry Council from February 4, 2005 to January 28, 2011;
11 and,

12 WHEREAS, Jocelyn Cohen was a stalwart spearhead in the initiation and
13 legislation of San Francisco's Landmark Tree Ordinance and remembers with regret the
14 loss of the first tree nominated after it was passed; and,

15 WHEREAS, Jocelyn Cohen served with authoritative influence on the Council's
16 Landmark Tree Committee; and,

17 WHEREAS, Jocelyn Cohen was fiercely forthright in advocating for education
18 and regulation for proper pruning of the trees of San Francisco's urban forest; and,

19 WHEREAS, Jocelyn Cohen was instrumental in accomplishing the Tree
20 Disclosure requirements and participating in the pilot Pocket Parks for Arbor Day; and,

21 WHEREAS, Jocelyn Cohen gave valuable advice and shared her arboreal
22 wisdom with the Council and was instrumental in furthering the objectives of the
23 Council; and,

24 WHEREAS, Jocelyn Cohen brought many forestry issues to the attention of the
25 Urban Forestry Council and the Board of Supervisors; now, therefore, be it

26 RESOLVED, The Urban Forestry Council extends its gratitude and commends
27 Jocelyn Cohen for her dedication to the Urban Forestry Council; and, be it

1 **FURTHER RESOLVED**, The Urban Forestry Council wishes Jocelyn Cohen well
2 in her future endeavors.
