

1 [Commendation for Urban Forestry Council Member Terry Milne]

2 Resolution commending Terry Milne for his service and dedication to the City and County of  
3 San Francisco's Urban Forestry Council and for improving San Francisco's urban forest.

4 WHEREAS, Terry Milne was originally appointed to the Urban Forestry Council by  
5 Mayor Willie L. Brown Jr. on April 11, 2003 to the seat representing a "member at large"; and  
6 served until the time when he was reappointed by the Board of Supervisors on March 3, 2009 to  
7 the seat "representing the community"; and,

8 WHEREAS, Terry Milne has served the City and County of San Francisco as a member  
9 of the Urban Forestry Council from April 11, 2003 to March 15, 2011, as a member of the Urban  
10 Forestry Council's Funding Committee from August 2003 to July 2007, and as a member of the  
11 Urban Forestry Council's Planning and Funding Committee from September 2007 to March 15,  
12 2011; and,

13 WHEREAS, Terry Milne was instrumental in establishing San Francisco's Urban Forest  
14 Plan, and,

15 WHEREAS, Terry Milne advocated for "significant tree" protections, participated in  
16 formulating proper tree pruning guidelines, and activating tree protection regulations; and,

17 WHEREAS, Terry Milne helped formulate the "Landmark Tree Legislation", amendments  
18 to Article 16 of the San Francisco Public Works Code, Section 810, Landmark Trees, which was  
19 adopted in 2007; and,

20 WHEREAS, Terry Milne recommended support for community-based permeable  
21 landscaping projects and the Better Streets programs; and,

22 WHEREAS, Terry Milne gave valuable advice and shared his arboreal wisdom with the  
23 Council and was instrumental in furthering the objectives of the Council on many issues that the  
24 Council has considered; now, therefore, be it,

25 RESOLVED, The Urban Forestry Council extends its gratitude and commends Terry  
26 Milne for his dedication to the Urban Forestry Council; and, be it

1 FURTHER RESOLVED, The Urban Forestry Council wishes Terry Milne well in his  
2 future endeavors.
