

I. Executive Summary

MED-Project LLC ("MED-Project") operates a Product Stewardship Plan for Unwanted Medicine from Households ("Plan") in the City and County of San Francisco, California ("County") under the San Francisco Safe Drug Disposal Stewardship Ordinance, Chapter 22, Division 1, Sections 2200-2219 ("Ordinance") and the San Francisco Department of the Environment ("Department") Regulation #SFE-16-01-SDDSO ("Regulation"). MED-Project's Plan, dated November 1, 2018, was approved ("Approved Plan") by the City and County of San Francisco Department of Environment (the "Department") on June 5, 2019. The Department issued a Notice of Determination on July 29, 2020, approving additional changes to the Approved Plan.

MED-Project has been operating in the City and County of San Francisco since 2017 and has served the residents by collecting over 135,000 pounds of Unwanted Medicine. MED-Project's outreach and education efforts have served over 65 million impressions to County of San Francisco residents, stemming from its comprehensive education and outreach program.

This MED-Project 2022 Annual Report in the City and County of San Francisco ("Report") describes MED-Project's activities in the County between January 1, 2022, and December 31, 2022 (the "Reporting Period") in compliance with Ordinance Section 2209. All capitalized terms used, but not otherwise defined herein, have their respective meanings set forth in the Ordinance, Regulations, or the Approved Plan.

A. Notifications in the Reporting Period

MED-Project submitted change requests and notices during the Reporting Period (notices providing status updates related to the effects of the COVID-19 pandemic are discussed in the COVID-19 Pandemic-Related Notifications section below). The change requests and notices included:

- Four quarterly Injector and Inhaler Reviews for reporting periods in 2021 and 2022 were submitted to the Department during the Reporting Period. The report met the Proposed Condition #4 detailed in the Notice of Determination issued by the Director on June 5, 2019.
- Four quarterly Help Desk Reports for reporting periods in 2021 and 2022 were submitted to the Department during the Reporting Period. The reports met Proposed Condition #7 detailed in the Notice of Determination issued by the Director on June 5, 2019.
- Four quarterly On-Demand Collection Services ("ODCS") Model Reports for the reporting periods in 2021 and 2022 were submitted to the Department during the Reporting Period. The report met Proposed Condition #12 detailed in the Notice of Determination issued by the Director on July 29, 2020.
- On June 5, 2019, the Department approved the Plan dated November 1, 2018, subject to conditions listed in the June 5, 2019, approval letter. Of note, Proposed

Condition #9 was waived by the Department via e-mail correspondence on January 28, 2022. Proposed Condition #9 required MED-Project to provide a minimum of 50 copies of the tri-fold brochure in English, and 25 copies in each other Required Language annually and upon request to each site on a list provided by the Department.

- On January 10, 2022, MED-Project notified the Department of the deactivation of five Mail-Back Distribution Locations, as listed in the notification.
- On June 10, 2022, MED-Project notified the Department of the deactivation of one Mail-Back Distribution Location and addition of another Mail-Back Distribution Location, as listed in the notification.
- On June 10, 2022, MED-Project provided a written proposal to address additional outreach activities to raise public awareness of the Program, as discussed in a May 12, 2022, call with the Department.
- On June 28, 2022, MED-Project submitted a request to the Department for an emergency change request due to the temporary closure of a hazardous waste incineration disposal facility ("Emergency Change Request").
- On July 15, 2022, MED-Project provided an update to the Department of the continued temporary closure of a disposal facility discussed in the June 28, 2022, notification, and requested extension of the Emergency Change Request and that an alternate disposal facility would continue to be used during the closure.
- On August 24, 2022, MED-Project provided another update to the Department of the continued temporary closure of a disposal facility discussed in the June 28, 2022, notification, and requested extension of the Emergency Change Request and that an alternate disposal facility would continue to be used during the closure.
- On September 20, 2022, MED-Project received approval from the Department of the Emergency Change Request for a change in disposal facility from Christopher Lester Special Waste Disposal Analyst San Francisco Environment Department to Dr. Victoria Travis, National Program Director for MED-Project. The Department stated that the approval is valid until the end of October 2022.
- On October 5, 2022, in response to the Department's July 22, 2022, and July 28, 2022, feedback on MED-Project's June 10, 2022, proposal, MED-Project provided a written proposal to address additional outreach activities to raise public awareness of the Program.
- On October 24, 2022, MED-Project provided another update to the Department of the continued temporary closure of a disposal facility discussed in the June 28, 2022, notification, and requested extension of the Emergency Change Request and that an alternate disposal facility would continue to be used during the closure.
- On October 24, 2022, MED-Project received approval from the Department of the Emergency Change Request for a change in disposal facility from Christopher Lester Special Waste Disposal Analyst San Francisco Environment Department to Dr. Victoria Travis, National Program Director for MED-Project. The Department stated that its approval would remain valid until the end of the Reporting Period.
- On October 25, 2022, MED-Project submitted an updated Product Stewardship Plan for Unwanted Medicine from Households.
- On December 15, 2022, MED-Project notified the Department that a vendor was no longer providing reverse distributor services under the Approved Plan.

- On December 21, 2022, MED-Project provided another update to the Department of the continued temporary closure of a disposal facility discussed in the June 28, 2022, notification, and requested extension of the Emergency Change Request and that an alternate disposal facility would continue to be used during the closure.
- On December 21, 2022, MED-Project received approval through February 2023 from the Department of the Emergency Change Request for a change in disposal facility from Christopher Lester Special Waste Disposal Analyst San Francisco Environment Department to Dr. Victoria Travis, National Program Director for MED-Project.

B. COVID-19 Pandemic-Related Notifications

On January 10, 2022, MED-Project submitted an eighth and final COVID-19 pandemic response notification, which indicated that no Kiosk Drop-Off Sites or Mail-Back Distribution Locations remained restricted.

C. Reporting Period Operations Overview

During the Reporting Period, priority was given to establishing Kiosk Drop-Off Sites throughout the County, and performing outreach to eligible pharmacies, hospitals, and clinics with on-site pharmacies, and Law Enforcement Agencies ("LEAs"). During the Reporting Period, MED-Project's Program collected and disposed of Unwanted Medicine from 60 Kiosk Drop-Off Sites and distributed Mail-Back Packages at 52 Mail-Back Distribution Locations. MED-Project installed 16 new Kiosk Drop-Off Sites throughout the County during the Reporting Period.

All Kiosks were installed in pharmacies that meet all local, state, and federal requirements and that executed agreements with MED-Project. In addition, promotional materials, including signage and/or brochures, were distributed to select existing Kiosk Drop-Off Sites and Mail-Back Distribution Locations.

MED-Project provided disposal instructions for Kiosk Drop-Off Sites and Mail-Back Services to Residents and continues to communicate with Kiosk Drop-Off Site Hosts to distribute outreach materials upon request, review procedures as needed, and improve overall Program design.

As outlined in the Approved Plan, the ultimate goal of the Program is to provide Residents with convenient, safe, and accessible methods to dispose of Unwanted Medicine. MED-Project anticipates a steady increase in the number of Kiosk Drop-Off Sites in 2023 as a result of ongoing outreach and Program activities, especially if there is increased retail chain pharmacy participation in the Program.

The following Sections of the Report respond to specific reporting requirements in Ordinance Section 2209 and Regulation Section 2. Each section of the Report restates the corresponding Ordinance and Regulation (where applicable) requirements and provides the required information. All figures are rounded to the nearest tenth place.

II. Participating Producers

A. Kiosks

MED-Project collected 25,574.2 pounds of Unwanted Medicine through Kiosk Drop-Off Sites.

B. Mail-Back Services

- MED-Project collected 425.7 pounds of Unwanted Medicine through the return of 737 Standard Mail-Back Packages.
- MED-Project collected 364.4 pounds of Unwanted Medicine through the return of 78 Injector Mail-Back Packages.
- MED-Project collected 47.9 pounds of Unwanted Medicine through the return of 47 Inhaler Mail-Back Packages.

C. Take-Back Events

There were no Take-Back Events during the Reporting Period.

D. Total Weight of Collected Unwanted Medicine

MED-Project collected a total of 26,412.2 pounds of Unwanted Medicine collected through all methods.

IV. Kiosk Drop-Off Sites, Mailers, and Take-Back Events

A total of 722 Standard Mail-Back Packages, 260 Injector Mail-Back Packages, and 93 Inhaler Mail-Back Packages were distributed directly to Residents. MED-Project identifies a total number of Mail-Back Packages provided directly to Residents because it is unable to verify whether the recipient is disabled and/or home-bound.

MED-Project distributed 200 Standard Mail-Back Packages to five Mail-Back Distribution Locations, during the Reporting Period.

A. Public Education Activities

MED-Project provided instructions for Kiosk Drop-Off Sites and Mail-Back Services to Residents through the Approved Plan. In addition, MED-Project maintained the MED-Project Website and toll-free Call Center to provide information pertaining to MED-Project disposal options and outreach materials. The MED-Project Website, toll-free number, and promotional materials, such as posters and brochures, were available in the Required Languages, including English, Spanish, Chinese, Russian, and Tagalog (Filipino). See Appendix H for examples of promotional materials. See Appendix I for promotional material distribution information. The MED-Project Website lists all Kiosk Drop-Off Sites and Mail-Back Distribution Locations. See Appendix J for screenshots of MED-Project Website pages and Appendix K for MED-Project Website page statistics.




Figure 1: Single System of Promotion Website- Find Convenient Locations Page (December 2022)

- During the Reporting Period, MED-Project continued to coordinate a single system of promotion website (www.med-projectsf.org) that directs Residents to a common webpage that provides information of both the MED-Project and the other program operator's active kiosk drop-off sites and mail-back distribution locations on a common map. The website also links to each program operator's website where Residents can request mail-back packages. See Figure 1, below. During the Reporting Period, there were 5,331 page views on the single system of promotion website.
- During the Reporting Period, MED-Project continued to coordinate a single system
 of promotion call center where residents who enter a San Francisco ZIP code are
 redirected to each program operator's call center based on an algorithm that
 equally distributed calls to each program.

- MED-Project coordinated a survey with the other program operator during the Reporting Period. The survey was provided to the Department and posted to the MED-Project Website on May 12, 2022.




Figure 2: Common Mark for the City and County of San Francisco

- MED-Project used the common mark on kiosks and the single system of promotion website. See Figure 2, below.

B. Outreach Activities

MED-Project conducted the following outreach activities during the Reporting Period: provided digital, radio, and television campaigns; distributed signage and brochures; posted information on social media sites; and sent email blasts. A list of the social media and email outreach promotion activities is provided in Appendix L.

During the Reporting Period, MED-Project met the goal of continued targeted media for a combined target reach percent of 75% at a 3+ frequency for the duration of at least four weeks, at least three times per year. The outreach activities achieved a combined reach percent of 100%, 88%, and 88% at a 3+ frequency respectively, each for a duration of at least four weeks and were conducted through a variety of media channels.

MED-Project performed the following activities to achieve the goals:

- Cross Media Campaign: January February 2022 (digital, social media, television, radio, and streaming audio) (22.8 frequency / five weeks)
- Cross Media Campaign: May June 2022 (digital, social media, television, radio, and streaming audio) (4.9 frequency / five weeks)
- Cross Media Campaign: October November 2022 (digital, social media, television, radio, and streaming audio) (4.7 frequency / four weeks)

The Target Rating Points calculated for the Reporting Period are 2,634.6 for digital media, 805.5 for television, and 261.0 for radio.

D. Evaluation Activities

Per the Approved Plan and Sec. 2206 (a) of the Ordinance, a biennial survey was conducted with the other approved program operator on January 20, 2022, and was completed by February 14, 2022. The results of the survey were posted to the MED-Project Website on May 10, 2022.

Twenty-three percent of Residents surveyed remembered having been exposed to messaging about safe storage and disposal of unwanted and/or expired medicines. Additionally, of those Residents surveyed, 24% reported having used Kiosk Drop-Off Site locations, 3% Mail-Back Services, and 3% take-back events to dispose of expired and/or unwanted medicines in the past year. Seventy-six percent of Residents who had an opinion, believed the medicine disposal Program was easy to use, and 74% of Residents, who had an opinion felt it was convenient.

The survey also showed that 64% of providers surveyed recalled having been exposed to messaging about safe storage and disposal of unwanted and/or expired medicines. Sixty-six percent of providers encouraged their patients to use designated drop-off locations to dispose of expired or unwanted medicines in the past year. Seventy-five percent of providers believed the medicine disposal Program was easy to use, and 73% of providers felt it was convenient.

VIII. Packaging Recycling

Ordinance Sec. 2209 (a)(10): "A description of how collected packaging was recycled to the extent feasible, including the recycling facility or facilities used."

As described in the Plan, while drug packaging is expected to constitute a significant amount of the waste incinerated under the Program, MED-Project has concluded that separation of inner and/or outer packaging from Unwanted Medicine and/or recycling of packaging would raise three significant concerns:

- 1. Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging;
- 2. Separating and recycling drug packaging could increase the potential for releases and leakage of Unwanted Medicine; and
- 3. Separating and recycling drug packaging could increase diversion risk by adding additional steps to the collection process and, because drug packaging is often used in drug counterfeiting, the drug packaging could be a diversion target itself.

For these reasons, the Program does not provide for the separation and recycling of packaging from Unwanted Medicine.

MED-Project education and outreach materials instruct Residents to return Unwanted Medicine at a Kiosk Drop-Off Site, via Mail-Back Services, or at a Take-Back Event, in its original container or in a sealed bag. These materials encourage Residents who transfer their Unwanted Medicine in a sealed bag to recycle all remaining packaging.

IX. Program Goals

Ordinance Sec. 2209 (a)(11): "A summary of the Stewardship Plan's goals, the degree of success in meeting those goals in the past year, and, if any goals have not been met, what effort will be made to achieve the goals in the next year."

A. Collection Goals




Figure 3: Map of Kiosk Drop-Off Sites and Mail-Back Distribution Locations during the Reporting Period

MED-Project strove to meet the Service Convenience Goals in Ordinance Section 2205(b)(1) during the Reporting Period through a combination of established Kiosk Drop-Off Sites and Mail-Back Distribution Locations as detailed in Appendix O; Kiosk Drop-Off Site and Mail-Back Distribution Location Reporting Period Results. Figure 3 provides a visual representation of how MED-Project satisfied the Service Convenience Goals during the Reporting Period. As described in Section VI of the Approved Plan, MED-Project set a long-term goal of increasing retail chain pharmacy participation to satisfy the Service Convenience Goals through the establishment of Kiosk Drop-Off Sites in seven of the 11 Supervisorial Districts. By the end of the Reporting Period, MED-Project had activated 16 chain pharmacies resulting in MED-Project meeting the Service Convenience Goals through the establishment of Kiosk Drop-Off Sites in six of the 11 Supervisorial Districts. During the Reporting Period, there were no Take-Back Events as a result of meeting the Service Convenience Goal through the establishment of Kiosk Drop-Off Sites and Mail-Back Distribution Locations.

As outlined in the Approved Plan, MED-Project set a collection expectation of 19,800 pounds for the 2019 collection period. MED-Project exceeded the Approved Plan's 2019 collection goals of approximately 19,800 pounds, during the Reporting Period. Specific details on Unwanted Medicine collection through Kiosk Drop-Off Sites and Mail-Back Distribution Locations is available in Section III: Collection Method and Weights,

Appendix B, Table 3: Unwanted Medicine Kiosk Drop-Off Sites and Appendix B, Table 4: Collection Method and Weights of this Report. MED-Project will evaluate future collection goals as part of the next Plan update.

B. Education and Public Outreach Goals

MED-Project met the Plan's short-term goals. MED-Project utilized data from 2017 to establish baseline education and outreach goals for the Reporting Period and future Reporting Periods. In 2022, there were no Take-Back Events, which resulted in no press advisories. See Appendix P; Baseline Data Summary. During 2017, no messages were left by Residents, resulting in no messages returned. In 2018 the Call Center was transitioned to a staffed 24/7/365 service, and, since then, all calls are answered with no messages left by Residents.

As outlined in the Approved Plan, MED-Project has evaluated the media and public outreach program, as well as feedback collected by survey in order to make adjustments and improvements to the Program. MED-Project will continue to maintain outreach activities in the County as required in the Regulation. MED-Project will also perform the additional outreach activities, as described in the October 5, 2022, Response to Department Feedback regarding MED-Project's Written Proposal submitted June 10, 2022. These additional outreach activities included:

- In-language outreach: MED-Project will use digital media strategy to conduct outreach activity for more inclusive reach of residents and effective communications. In 2023, MED-Project plans to include social media and digital activity in other languages (Chinese, Spanish, Tagalog (Filipino), and Russian) as part of its continued efforts to build awareness.
- 2. Partnership with hospitals, pharmacy chains, and healthcare consortiums: In 2023, MED-Project will develop an education package containing information that can be shared with pharmacy chains, hospitals, and healthcare consortiums for the purpose of circulating via their own existing channels of communications with patients and providers.
- 3. Upgrades MED-Project has made in the last 6 months relating to accessibility and language translation tools: In March 2022, MED-Project launched the refreshed www.med-project.org website with a link to accessibility tools and a translation link with over 100 languages, which utilizes Google Translate for autotranslations for every text page.

Additionally, MED-Project may revise and/or add communications materials based on changes to the Plan.

C. Collector Outreach

MED-Project continued collector outreach by issuing letters to all nonparticipating or new retail pharmacies on January 24, 2022.

X.Program Costs

Ordinance Sec. 2209 (a)(12): "The total expenditures of the Stewardship Plan during the reporting period."

The total Program cost for the Reporting Period was \$866,325.39.

Description: MED-Project was notified by its Vendor of two apparent shipping discrepancies for unwanted medicine boxes and liners (the "Boxes and Liners") originating from the County of San Francisco which were declared by the carrier to be lost in transit. MED-Project understands that there have been rare exceptions in which the Carrier cannot deliver a package to its destination or return it to the shipper for reasons including, but not limited to, the loss of shipping information, such as a damaged shipping label. The Vendor has reported that the Carrier has policies and procedures for managing such packages, including destruction at a permitted medical waste incinerator.

Corrective Actions Taken: For each of these shipping discrepancies, MED-Project requested the Vendor provide a detailed report of its investigation and findings including any information on the whereabouts of the Boxes and Liner. In addition, MED-Project requested: (1) any other outcomes from investigations into the apparent Box and Liner shipping discrepancy; (2) any reports Vendor makes regarding this apparent discrepancy to law enforcement or government agencies; (3) any law enforcement or government agency involvement with this apparent discrepancy; (4) any legal proceedings involving this apparent discrepancy, and (5) any changes in policy or procedure that Vendor has or is planning to make as a result of the apparent discrepancy.




Figure 10: MED-Project Brochure Russian (back)




Figure 12: MED-Project Brochure Tagalog (back


Figure 13: MED-Project Kiosk Poster English


Figure 14: MED-Project Mail-Back Poster English


Figure 17: MED-Project Kiosk Poster Chinese




Figure 13: Website Home Page (December 2022)




Figure 24: Website Mail-Back Services Page (December 2022)




Figure 25: Website Convenient Locations Page (December 2022)





Figure 26: Website Take-Back Events Page (December 2022)




Figure 27: Website Check the Package Page (December 2022)




Figure 28: Website Learn Page (December 2022)




Figure 29: Website FAQ Page (December 2022)




Figure 30: Website Contact Page (December 2022)




Figure 33: Example of Social Media Post (Social Media Campaign #1)




Figure 37: Digital Advertisement Campaign (Digital Campaign #2)




Figure 38: Example of Social Media Post (Social Media Campaign #2)




Figure 40: Invoice (Radio Campaign #2)




Figure 42: Digital Advertisement Campaign (Digital Campaign #3)




Figure 43: Example of Social Media Post (Social Media Campaign #3)




Figure 44: Media Report (Connected TV Campaign #3)




Figure 45: Invoice (Radio Campaign #3)
